Department Head Reports:

Dog Control Officer Holmes:

- Dog Control Officer, Bill Holmes reported having a few complaint calls. Bill had his New York State Annual Inspection and all went well.
- Bill presented the board with a quote for a security system for when the time comes to update or replace the system that is in place at this time. Supervisor Willis suggested we apply for a grant through the Justice Department in the fall. This will allow time to have three quotes available at the time of discussion.

Highway Superintendent James Shear:

- Highway Superintendent, James Shear reported the highway crew have started using the Broom to get things cleaned up.

Supervisor Willis looked into a solution and was given a few ideas as to how the lighting could be redirected so it would be less distractive to traffic traveling down Cherry Valley Hill Rd.

Resident Lewis Jackson asked if the leak in the shop roof had been resolved. Supervisor Willis has spoken to Joe Osman to see if he could fix the seam where the leak is.

Fire Chief, Nick Collyer from the Glen Aubrey Fire Department announced the Fire Company are getting ready for their 2022 Fund Raisers. A Chicken BBQ will be held on May 29, 2022 at Greggs in Whitney Point.

A pancake breakfast is on the agenda, no date has been set at this time.
