Department Head Reports:

Highway Superintendent, James Shear:

- Highway Superintendent, James Shear reported concern with the blacktop on Rabbit Path Road during the extreme heat. He has been in touch with Vestal Asphalt to see what can be done to rectify this problem.
- The Oil & Stone delivery is expected to be here by this Friday.
- The concern with the run off on Howland Hill was addressed. The residents expressed their gratitude with the job done.
- Councilman Scott Whittaker brought to the councilmen attention the bids for the Road Broom were in. Scott proceeded to open the bid for consideration and approval.
 Councilman Baker asked for some time to review the details in the contract. Therefore, the decision to approve the purchase was tabled until the next meeting in August.

Town Clerk- Renny Zanker:

• Town Clerk, Renny Zanker reported the upgrade installation for better service with Spectrum is now in place and the speed of internet has been tested and is running as expected. The new email addresses are being worked on.

Old Business:

- The councilmen and highway superintendent discussed the Road Broom Bid Warranty. The only bid received was from SEI Equipment. It is open for 60 days and specific details will be reviewed by councilmembers in depth. This will be tabled until the next board meeting in August.
- The topic of the Town of Nanticoke Highway Superintendent Vehicle Use Policy was reviewed a second time by Town Attorney Robert McKertick to clarify and confirm what was agreed upon in last month's meeting.

have them back before the weather changes in the late fall.
