Reports from Department Heads:

Supervisor Wills reported for Mark See, Code Enforcement. There are currently 3 or 4 new home projects. Another cell tower company is looking into erecting another cell tower. More information to come in the future. A new property owner is looking at subdividing land on Cherry Valley Hill Road for a 10 home sub-division (trailer park). No further information on that project at this time.

Dog Control Officer, Bill Holmes had nothing new to report. Had 1 nuisance call over the holiday period.

Supervisor Willis reported for Renny Zanker, Town Clerk. She has been working on a new combined phone system, so we have one carrier for landline and cell phones. Supervisor Willis recommended the purchase of 3 cell phones: 1 for the Supervisor, 1 for Dog Control, 1 for Highway Supervisor. Requested Council review the Verizon information provided for the purchase of 5 new office phones. The current phone system through Frontier is 20+ years old and combining services for landline and cell service will save the town approximately \$100 per year.

Highway Superintendent James Shear:

- Jake Slack deserves his gratitude for his exemplary training and supervising of the highway crew. The crew is very well trained in all that they do, including the younger members of the crew who have only been driving CDL for a short time.
- Councilman Holden, asked if the board could meet with the crew on a regular basis. To get to
 know them better, and hear their ideas and concerns. Lawyer stated unless there was a formal
 meeting arranged with all four councilmen in attendance, and which you would have to pay the
 crew to attend. It would be best to have something more informal.
- Discussion regarding purchasing new(er) pickup truck, replacing the 2012 Chevy. Also, the greater need for a "road sweeper." Jim Shear to do more research on both and provide the board members with a plan and more detailed information at next meeting.

Nick Collyer, Fire Chief, reported they recently purchased a larger "Extraction Set," that will help with larger extractions, and 3 ramps. Membership is doing well.

Supervisor Willis asked the guest in attendance if they had any questions/concerns/comments.

Louis Jackson asked if the "284" Agreement has been filed for this year. Highway Supervisor will be completing shortly. Lawyer did mention that it would be best to ensure that it was submitted by February 1st.
