# Department Head Reports:

# Town Clerk, Renny Zanker

- Hunting and fishing license sales are increasing. Renny and Sue continue to work with former Judge Struble, getting the courts records from years past to current marked and ready for retention or destruction.
- Former Judge William Struble gave an explanation of what has been done, what needs to be done, and permission that has been granted from the Judicial Courts to have certain records destroyed.

# Highway Superintendent, Robert Hoag:

- Highway Superintendent, Robert Hoag reported all the roads scheduled for oil and stone were done.
- The new truck was picked up on Monday. Bob and Justin pulled a full load up Baker Hill with no problem. Bob shared a concern with the turning radius that may slow the process of plowing on the seven dead end roads.

### Code Enforcement – Shaun Oliver:

• Code Enforcement Officer, Shaun Oliver had issued a couple of permits. So far all is moving along in a positive direction with no complaints.

# Dog Control Officer - Bill Holmes:

 Dog Control Officer, Bill Holmes discussed Local Laws that need to be revised. There have been some problems with barking dogs and dangerous dogs. Attorney McKertich asked Bill to get the information necessary to his office for review. He has had a few complaint calls. Bill thanked Fire Chief Nickolas Collyer who assisted Bill with a few dogs. • Councilman Holden and Councilman Slack discussed the property owner's responsibility to keep others safe while on the property of the dog owner.

# Town Supervisor – Roy Willis:

- Supervisor Willis thanked former Judge, Bill Struble for all his dedicated service as judge and the
  volunteer work, he is doing to help Nanticoke's Town Justice, Judge Bradely Balwin. This would
  mean Judge Balwin would not inherit records from the 60's to the end of Former Judge Struble's
  term in office.
- Supervisor Willis reached out to Mari G. (grant writer) regarding some grants that have been submitted for building improvements.
- Supervisor Willis spoke with Fire Chief Nickolas Collyer regarding grants that are available for the fire department.
- Supervisor Willis thanked the Fire Chief Nickolas Collyer, and the Fire Stations Treasurer, Steve Carter for meeting with Supervisor Willis and Councilman Baker. To discuss what can be done to help our Glen Aubrey Fire Company.

# Town Attorney, Robert McKertich:

- Town Attorney, Bob McKertich answered questions that were brought to his attention from the last meeting. These questions were also answered including the contracts and how the process works. Supervisor Willis furthered explanation of how monies and contracts work.
- Attorney McKertich explained what is and is not allowable for purchases under the CHIPS Monies.

# Old Business:

• Discussion was held regarding the approval for the Local Law NO. 1. It was decided to revisit at a later date.

#### Guests:

- A resident brought his concerns and estimates to the supervisor and councilmembers regarding damages to his vehicles and garage. This will be resubmitted to the town insurance company for review and consideration. Town Attorney, Robert McKertich explained what the options are if the municipality is not liable for the damages. Supervisor Willis asked council and the town attorney what they thought would be the next steps for restitution if the insurance denied coverage. The clerk will submit the information provided to the insurance company first thing in the morning and request a response by Friday.
- Glen Aubrey Fire Company Treasure, Steve Carter, gave explanation of expenses and duties of the Glen Aubrey Fire Crew.
- Fire Chief President, Amanda Collyer went into further detail to Maine Ambulance coming along side to assist the Glen Aubrey Fire Company. This will give better response time and extra back up for residents' emergency calls.
- A resident stated they have attended the town board meetings for a little over three years and wanted to praise the supervisor, supervisor's secretary, board members, highway superintendent, clerk, deputy clerk, code enforcement officer, dog control officer, and assessor for their hard work and efforts in keeping the town residents' best interest and serving the town's residents. The resident has witnessed that much progress has been made to make the town better.
