Supervisor Willis mentioned to the councilmembers and the public attending the meeting we are considering hiring Grant Writer, Mari Giurastante who had attended Septembers Board Meeting and shared what she could do to help the town with grant monies we may qualify for. Supervisor Willis stated that Town Attorney will review the proposed contract with Ms. Giurastante, which will be presented to the Town Board at the November 2022 meeting.

Department Heads:

Dog Control Officer, Bill Holmes:

• Bill introduced himself and stated he had received a couple of dog complaint calls. Resident Arlene Spinelli spoke with Bill regarding a concern with a stray dog running down Cherry Valley Hill Rd.

Code Enforcement Officer, Mark See:

• Mark was unable to attend the meeting. Supervisor Willis has been in touch with Mr. See to see if Mark had any updates for the councilmen or residents. Supervisor Willis asked everyone to keep Mark in their thoughts and prayers for a full recovery.

Clerk Renny Zanker:

- Renny continues to work with Rick Cicciarelli with upgrading the system.
- Nancy Rutkowski is helping with old files and getting the files ready for the judge's retirement.

Supervisor Willis asked all attending the meeting to introduce themselves and take a few minutes to ask any questions or voice concerns or comments.

Highway Crewmember Chris Slack introduced himself and asked to set the record straight in regards to what he has heard being said about his involvement with the Fairbanks Road matter. When asked, Mr. Slack stated that he has maintained the road by mowing it every year for his personal use to hunt.

Councilman Holden had comments in regards to Fairbanks Road, that he had interviewed those who may have information that Mike felt needed to be brought to the councilmember's attention in regards to the resolution presented in the prior meeting.

Resident Chuck Forkey stated he was a former councilman, and was present during the time when Fairbanks Road matter had been brought to the table and was put to sleep. Mr. Forkey asked that board members to review the past meeting minutes at the time this matter had been originally brought to the councilmen.

Motion to approve the minutes from the previous meeting in September were tabled until November's meeting.

Resident Josh Clark suggested a mass email be sent to all Nanticoke Taxpayers and Voters for access to the meeting minutes.

Guest speaker Matt Hildebrandt introduced himself and spoke about a Small Community Grant Funding Program that would be available in the spring. Matt will be running for office and told the residents any questions they may have to feel free to reach out to him.

New Business:

Councilman Mike Holden and Highway Superintendent James Shear had spoken about the future idea of putting the garages and town offices over on the property near the Nanticoke Salt Barn.

A suggestion was made to change the date of the next Nanticoke Town Board Meeting, as the date scheduled for November 8, 2022 conflicts with Election Day. Motion was made to schedule the next Town Board Meeting for Thursday, November 10, 2022 at 7:00 pm.
